Rules and Guidelines for Parents and Club Members

1. Staff will treat every member with respect. Members are expected to show the same courtesy to staff and other members.
2. Members are allowed at The Club only when it is open. Parents are asked to pick up their children **by closing time**. *The club reserves the right to call the sheriff's department at any time if a child is not picked up by closing.*
3. The Boys & Girls Club of South SLO County has an open door policy and is not a day care center. Parents are asked to encourage their children to remain in the building unless a staff member is with them.
4. All members entering the Club must check in at the front door.
5. Payments made to the Boys & Girls Club are non-refundable.
6. No clothing pertaining to gangs, drugs, alcohol, sex or profanity will be allowed on Club property at any time. Shoes must be worn at all times.
7. Members have an obligation to take care of equipment, furniture and the building. It is your Club: Take pride in it!
8. Phone calls are allowed for **emergency only**. Staff may make phone calls for members who need a ride home.
9. Horseplay, fighting, cursing and name-calling are not allowed.
10. Snacks and drinks may be eaten only in designated areas. Sodas are not permitted at the Club.
11. Bicycles must be parked at the bike rack with a lock and chain provided by the member. The Boys & Girls Club is not responsible for lost or stolen bikes.
12. Membership card must be shown to check out equipment. Cards will be held until the equipment is returned. **The membership card is the sole responsibility of the card holder and cannot be used by anyone else!** There will be a fee of \$1.50 to replace cards.
13. Walkmans, stereos, Gameboys or any type of video games are not allowed at the Club.
14. Boys & Girls Club is not responsible for lost articles such as jackets, skateboards etc.
15. It is the **parent's responsibility** to inform the child to stay at the club.
16. During parts of year when it gets darker earlier, members that walk home may be asked to leave before it gets dark to ensure their safety.
